Dogs will be box started. Dogs too tall to fit in the box will be hand slipped.

Roll Call at 9:30 a.m., both days

ELIGIBILITY for CARA:

- All Sighthounds recognized by a Registering Body.
- Dogs must be one year of age or older on the day of the meet to participate.
- Dogs participating in the race meet must have individual registrations with CKC, AKC, or other Recognized Registry.
- Dogs participating in the race meet must be either certified, or exempt. However, **ALL dogs will be on probation for 2 race meets.**
- Hounds must be registered with CARA to participate in official races. Dogs not already registered must submit payment of \$2.00 and a photocopy of their individual registration papers with their entry. CARA registration is for the life of the dog.

ELIGIBILITY for AOK9:

- ALL breeds and mixed breeds are eligible. **NB: Lurchers and Longdogs will be running under AOK9.**
- Dogs must be one year of age or older on the day of the meet to be entered.
- Dogs participating in the race meet must be either certified, or exempt.
- Dogs must be registered with AOK9 to participate in official races. Dogs not pre-registered directly with AOK9 must submit a copy of the **“RACE Individual Registration Application”** with the specified documents (<https://aok9racing.weebly.com/uploads/1/1/1/1/11113828/aok9application.pdf>), along with \$3.00 CDN for registration fee. Registration is for the life of the dog.

Entry Fees – Please note: fees listed are PER DAY (i.e., \$20.00 is for ONE DAY ONLY; both days is \$40.00)

Payment MUST accompany Entry Forms; dog/s will not be considered entered until entry fees have been received

- \$20.00 for 1st dog – **deadline June 02, 11:59 pm**
- \$15.00 each for subsequent dog/s – **deadline June 02, 11:59 pm**
- \$5.00 Puppies/Singles/Practice (limited spaces, so please register quickly) – **deadline June 02, 11:59 pm**
- \$2.00/dog for CARA lifetime registration - this applies to all FTE dogs.
- \$3.00/dog for AOK9 lifetime registration (if dog hasn't been pre-registered directly with AOK9).

To enter/register dogs for the meet:

- Please fill out the entry form listing the dog/s which will be participating in the race meet, along with the signed waiver, and send it PDF to: WhippetNV@gmail.com
- Payment is to be made by e-transfer to WhippetNV@gmail.com
- **Entries will be accepted until 1 hour before Roll Call for an additional \$5.00 fee (\$25.00 1st dog, \$20.00 subsequent dogs)**

Misc. info:

- **Roll call at 9:30 a.m.**
- Drag line will be used
- All dogs must wear appropriate gear: racing blankets, muzzles, and **catch collars**.
- **Blankets and Muzzles will be available for use at the rate of \$5.00/day or \$7.50 for the weekend.**
- Dogs that are excused or disqualified will not be reimbursed.
- Bitches in season or lame hounds will have their entry fee reimbursed provided notice is given prior to, or at roll call.
- People exhibiting **unsportsmanlike conduct**, or creating **DRAMA**, will be asked to leave, and may not be allowed to return in the future. Entry fees will be forfeit.

Location:

#69, South Cooking Lake (~20 minutes east from South Common in Edmonton)

- Take Hwy 14 East (towards Tofield) from Edmonton. 2km past where the divided hwy ends, on the left is the hamlet of South Cooking Lake. Turn in to South Cooking Lake. Drive up to the **STOP** sign. Drive across the street, past the front of the liquor store and down the hill; **#69 is the first place on the left**. Gate will be closed. Drive in and follow the driveway/trail past the front of the house to the back field.
- Or, use GPS by entering "**Spirit Quest Liquor**". Drive to the liquor store, past the entrance and down the hill.

FYI, a few words about Racing....

Straight racing is somewhat different from Lure Coursing. To run a successful race meet, participation is a requisite – and an enjoyable way to spend the day while racing. Numerous officials are required: Foul Judges, Finish Judges, Inspection Committee, Starter, so please participate in whichever capacity you would find most rewarding.

Please read the following and let us know which position/s you would like to volunteer for (some positions can overlap):

- **Inspection Committee** consists of 2 people who inspect entries at Roll Call. This includes checking for bitches in season, lameness, and adequacy of muzzles. Inspection committee is welcome to participate in other functions as well.
- **Starter** (and assistant Starter) consists of 2 people, who make sure people get to the line race ready, check each dog's equipment, make sure dogs have the correct blankets, are properly muzzled, and help load dogs into the boxes. They may also briefly tease the dogs with the lure, then release the dogs once the lure starts moving. For dogs being hand slipped, the Starter also calls the TallyHo! and watches for, and calls pre-slips. Starter(s) may double as Foul Judges.
- **Foul Judges** consist of a minimum 4 people, equally spaced along the track. Their job is to watch the dogs for interfering with another dog either playfully or aggressively. If there is interference, it's the foul judge's job to report the incident to the race secretary.
- **Finish Judges** consist of a minimum 2 people. They are at the finish line, one on either side of the track. At the end of each race, each judge should immediately record the order of the finish using either blanket colour or number, without conferring with each other or anyone else.

The Race Program

There are 3 Programs of racing in both CARA and AOK9 racing. All races shall be maximum 4 dogs. Dogs run within their breed for CARA; however, **for 1 dog entries, mixed stakes may be run at the discretion of the handlers.** For AOK9, mixed breeds will be run with dogs of similar type. "Type" is defined as a combination of size, proportion, and/or running style.

All dogs will be box started, with the exception of dogs/breeds that are too tall to fit comfortably in the start box. Dogs that don't fit will be hand slipped; a dog that's pre-slipped is automatically placed last in its race.

If the majority of participants are new to Straight Racing (FTEs), dogs may be randomly drawn into races with dogs of contrasting abilities. After the first race, dogs should end up in races where they're more evenly matched.

Dogs that have not been certified may only run as "Singles".

The Straight is 200 yards, with a 50+ yard run-out. A drag line, with either a squawker and/or plastic bag/s will be used as lure.

The U-val is 350 yards, with a 50+ yard run-out. A drag line with plastic bag/s will be used as lure.

- **Anyone exhibiting unsportsmanlike conduct, or creating *DRAMA* (as defined by Urban Dictionary), will be asked to leave the premise and will not be refunded any monies. Such people may be barred from participating in future events.**
